ICTR General Staff Meeting

"Renew Efforts and Commitment Toward Timely Completion of Tribunal's Mandate," ICTR Staff Urged

On 10 February 2005, at the annual staff meeting, the leadership of the International Criminal Tribunal for Rwanda asked staff members for their renewed effort and commitment toward the timely completion of the Tribunal's mandate.

The President, the Prosecutor and the Registrar of the ICTR met with about 700 staff to summarize the Tribunal's activities and accomplishments for 2004

and to fix the agenda of programs for 2005. The officials thanked the staff for their continuous effort to enhance the achievements of the ICTR and called for an increase in their collective effort in all areas of the Tribunal's operations.

The Registrar. Diena Adama congratulated the ICTR President, Judge Erik Møse, and the Prosecutor, Hassan Bubacar Jallow, for their success in getting support and resources for the ICTR during 2004. He said that their efforts convinced the Security Council and Member States to fully support the implementation of the completion strategy of the Tribunal and to resolve the financial and personnel difficulties that the Tribunal faced in 2004.

The Registrar highlighted as achievements of the Tribunal, the implementation of the Outreach Programme and the creation of a support and focus group in Dar-es-Salaam called "THE FRIENDS OF ICTR". The group is composed of seven diplomats. The objective of "THE FRIENDS OF ICTR" is to sensitize the member States about the work of the Tribunal and to assist strategically the ICTR to discharge its mandate within the framework of the Completion Strategy.

Other achievements of the ICTR were:

- Securing financial contributions in support of the activities of the ICTR from various donors;
- Streamlining of internal processes and numerous reforms undertaken by the management;
- Implementation of important costsaving measures and introduction of new information technology tools;
- Success of the Internship and Legal Researchers Programmes, which hosted a total of **152** interns and **23** legal researchers, representing **42** countries;
- A total of **283** witnesses for both the Prosecution and the Defence were brought to Arusha from all over the world, for the purpose of testimony.

President Erik Møse highlighted some of the judicial achievements of the ICTR since June 2003. He said the Tribunal issued judgements involving 12 accused. This brought the total to 25 persons judged since the beginning of the trials in 1997. There are ongoing trials involving 25 additional accused.

The President said one challenge facing the Tribunal in 2005 was increasing courtroom capacity and scheduling new trials while handling the 8 trials already





The first trial at the ICTR started in January 1997, following the arrival of the first accused to Arusha in May 1996. As of March 2005, the ICTR has handed down 17 judgments involving 23 accused. Twenty of them were convicted and three acquitted.

The judgments delivered so far involve one Prime Minister, four Ministers, one Prefect, five Bourgmestres and several others holding leadership positions during the genocide of 1994.

In addition to these 17 judgments, eight trials were in progress as of March 2005, involving a total of 25 accused. They include eight Ministers, one Parliamentarian, two Prefects, three Bourgmestres, one Councillor, three military officers, and others holding leadership positions.

• Jurisprudence

The *Akayesu* case decided by the ICTR in 1998 was the first in which an international tribunal was called upon to interpret the definition of genocide as defined in the Convention for the Prevention and Punishment of the Crime of Genocide (1948).

The Chamber also defined the crime of rape. It underscored the fact that rape and sexual violence may constitute genocide in the same way as any other act of serious bodily or mental harm, as long as such acts were committed with the intent to destroy a particular group targeted as such.

The guilty plea and subsequent conviction of Jean Kambanda, former Prime Minister of Rwanda, set a number of precedents. This was the first time that an accused person acknowledged his guilt for the crime of genocide before an international criminal tribunal. It was also the first time that a head of government was convicted for the crime of genocide.

The 2003 ICTR *"Media Case"* was the first judgment since the conviction of Julius Streicher at Nuremberg after World War II in which the role of the media was examined in the context of international criminal justice.

• ICTR Outreach Program

The ICTR has a strategic program of outreach to diverse audiences, using various communication channels. Particular attention is given to mass media and interpersonal communication in order to convey efficient and persuasive messages to targeted audiences inside and outside Rwanda.

The focal point of the Outreach Program is the Information Centre *Umusanzu mu Bwiyunge* in Kigali. The Information Centre was inaugurated in September 2000. The Centre provides a range of programs and opportunities to increase public understanding of the Tribunal's work through briefings, lectures, workshops and films. The Information Centre facility is fully utilized by the Rwandan public, particularly students and researchers, who wish to get first-hand information about the Tribunal.

The Tribunal continues its proactive public awareness campaign through seminars and exhibitions worldwide. Journalists from various countries in Africa and international news agencies have been invited to Arusha to cover important events in order to generate awareness of the Tribunal's activities.

Cooperation with Member States

• Rwanda Pleased with Tribunal's Decision to Hand Over 15 Dossiers of Genocide Suspects

Reports from Kigali state that Rwanda is pleased with a move by the UN International Criminal Tribunal for Rwanda (ICTR) to hand over to Kigali dossiers of 15 genocide suspects, who are still at large, for prosecution This was confirmed on 24 February by the Rwanda Deputy Prosecutor Martin Ngoga.

The 15 names are of some big fishes wanted for genocide," he said.

However, he declined to disclose the names, saying they would remain confidential until arrests were made. He said once arrested, the suspects would face charges of genocide and crimes against humanity in Rwandan courts.

On Wednesday 23 February 2005 the ICTR Prosecutor Hassan Jallow handed over the dossiers on to the Rwandan prosecutor, Jean de Dieu Mucyo. The Tribunal's Chief of External Relations and Strategic Planning Mr. Roland Amoussouga said investigators had completed dossiers for some years. The handing over of the dossiers, he said, was part of the tribunal's completion strategy as directed by the UN Security Council. The court is expected to complete its work by 2008.

Ammoussouga said once arrested, the suspects would be tried in Rwanda but according to UN standards.

Rwanda Ready to Receive ICTR Convicts

Rwandese authorities assured an ICTR delegation at the end of January 2005 that their judicial authorities are ready to receive in Rwanda some of the genocide perpetrators who are already convicted but currently detained at the UN detention facility in Arusha so that they can serve their sentences where they committed their crimes.

This was said by the Minister of Justice and Institutional Affairs Mrs. Edda Mukabagwiza in Kigali after meeting senior officials from the ICTR led by the Registrar, Mr. Adama Dieng.





The Minister told the press that the Rwandan Government had fulfilled all the judicial requirements for this program and all the facilities were in accordance with international law.

Speaking at the same meeting, the State Minister for Foreign affairs and Regional Cooperation, Mr. Mitali Protais said that the Government and the UN crimes tribunal held talks which, among others, were aimed at bringing some of the Genocide cases and convicts to Rwanda for trial. The high level meeting brought together top judicial officials including the Justice Minister, Edda Mukabagwiza, The State Minister for Foreign Affairs and Regional Cooperation, Mr. Mitali Protais, The Prosecutor General Jean de Dieu Mucyo and his Deputy, Martin Ngoga in addition to the government representative at the Tribunal, Aloys Mutabingwa.

ICTR Prosecutor Visits Republic of Congo

On 17 February 2005 the Prosecutor of the UN International Criminal Tribunal for Rwanda (ICTR), Hassan Jallow, visited the Republic of Congo and called upon the Congolese Government to co-operate and strengthen relations with the Tribunal, particularly in the facilitation of arrests and prosecution of suspects in the 1994 genocide in Rwanda.

The Prosecutor said the ICTR needed such cooperation because it did not have police to arrest the suspects. It was only through state organs of member states that suspects, following petitions presented by the ICTR, can be arrested and subsequently transferred to Tribunal in Arusha to face prosecution, he said.

Mr. Jallow commended the Government and the people of the Republic of Congo for their previous support to the work of the Tribunal. The Congolese authorities have previously assisted the Tribunal in the arrest and transfer of some of the accused persons who are presently facing charges in Arusha.

The Prosecutor added that the ICTR was looking for several suspects who are still hiding in several African countries and in Europe.

Outreach Activities in Rwanda

Rwandan Legal Librarians Attend ICTR-Organised Training in Kigali

From Monday, 14 February to Friday 18 February 2005, Rwandan Legal Librarians attended an ICTRorganised training seminar in information and documentation techniques at the Tribunal's Centre in Kigali. About 20 participants drawn from the Supreme court, the office of the Prosecutor General and from the Ministry of Justice attended the training that is part of the Tribunal's outreach programme.



Speaking at the opening ceremony. on behalf of the ICTR's Registrar, Mr. Adama Dieng, Mamoudou Touré, the ICTR chief of administration in Kigali praised the Rwandan Government for its initiative in setting up court libraries in various provinces of the country.

"Your project is a good one and it fits into the government's policy towards the promotion of peace and reconciliation in Rwanda. Indeed I am happy to note that though the tribunal and the Rwandan Government are working at different levels, they are both aiming at the same ideal, that of justice ,reconciliation and peace in the country." He added.

Speaking to journalists, Mrs Odette MURARA, the Secretary General of the supreme court who represented the court said that the seminar has come at the right time when the government is trying to set up court libraries in all the provinces and we are sure that this seminar will contribute a lot to their success.

"This training will assist Rwandans in general and our judicial staff in particular to know more information about the ICTR so that we can be able to continue the mission of the Tribunal even after its completion in the limited time remaining." She pointed out.

Mrs. Murara added that the government is appreciating the assistance the Tribunal is providing in the rehabilitation of Rwanda's judicial sector and there is no doubt that the good cooperation existing between the Rwandan Government and the Tribunal will be continuous.

This training session is the first of a series of three being offered to librarians from Rwandan academic and legal institutions. The second training session will focus on the use of WINISIS, a library management software while the third will provide training in online information searching.

The training seminars are a part of the capacity building programmes that the ICTR continues to undertake in order to strengthen the Rwandan judicial system.

in progress. He noted that a fourth courtroom now under construction will make it possible to ensure even more steady progress in concluding the multi-accused cases which require many trial days.

A second challenge will be recruitment of staff to fill vacancies which have existed since 2004 and the retention of staff. He urged the Registry to move expeditiously in recruiting staff now that the hiring freeze has been lifted.

The Prosecutor, Hassan Bubacar Jallow stressed that 2005 should be no less -perhaps even more challenging. The New Year has seen the passage of a significant stage in the completion process with the conclusion of investigations into new cases by 31st December 2004. With the assessment of the evidence gathered on the targets then under investigation, his Office should be reaching another important milestone later in the year, i.e. the filing of the last new indictments - if any - for the genocide of 1994. In addition, the Office of the Prosecutor will, in the course of the year, devote particular attention to ensuring the trial readiness of the cases of the rest of the detainees. The apprehension of the indicted fugitives will likewise be the subject of a sustained and well-organized tracking programme. All this of course will be in addition to maintaining the progress of the on-going trials.

The Registrar concluded his address by thanking the staff for its full support and impressive contributions which made his initial tenure a success and possible for the Secretary-General of the United Nations to ask him to accept a further extension of his current contract as Registrar for four more years, until February 2009. He said he humbly accepted the offer.

The President, the Prosecutor and the Registrar wished all staff a happy new year and committed themselves to greater collaboration with all ICTR staff members.

VIP Visits ICTR

• Former Ghanaian President Visits the Tribunal

On Tuesday 22 February 2005 the former Head of State of Ghana, Jerry Rawlings, visited the International Criminal Tribunal for Rwanda (ICTR) in Arusha.

During his visit Rawlings said he was not opposed



to the ICTR being used to try alleged perpetrators of atrocities in the Darfur region of Sudan upon the completion of its mandate in 2008.

So long as the instruments do exist both in terms of machinery and personnel to ensure fair justice is done, I have no problem with wherever these courts are held," added Jerry Rawlings.



He commended the work being done by the ICTR saying it was so far impressive. He also appreciated the increase in speed in adjudicating the trials before the Tribunal.

The former Ghanaian head of State was in Tanzania as a special envoy for the United Nations for HIV/ AIDS.

A few months ago the US Government proposed the establishment of an African War Crimes Tribunal (AWCT) to try the atrocities committed in Darfur, which it has described as genocide. The issue is still under discussion.

Judicial Proceedings

• Trial of Lt. Col. Muvunyi Begins



On 28 February 2005 the Trial of Lieutenant Colonel Tharcisse Muvunyi the former Commander of the Rwandan military school, *Ecole des Sousofficiers* (ESO), began before Trial Chamber II of the International

Criminal Tribunal for Rwanda with the prosecution's opening statement.

The accused, 52, is charged with five counts including genocide, or complicity in genocide, (as an alternative to the genocide charge), direct and public incitement to commit genocide, and crimes against humanity (rape and other inhumane acts). According to the indictment, Muvunyi was part of the military and political operation which incited the population, armed them and encouraged massacres against the Tutsi and moderate Hutus.

Trial Chamber II composed of judges Asoka De Silva (Sri Lanka), presiding, Flavia Lattanzi (Italy), and Florence R. Arrey (Cameroon) heard Mr. Hassan

According to the Prosecution, the evidence will show, after testimony by witnesses and experts, that the accused encouraged soldiers and militia to kill more than 100,000 Tutsi in Butare Prefecture.

denied all the allegations against the accused and argued that the accusations are not mentioned in the indictment.

Tharcisse Muvunyi was arrested in the United Kingdom on 5 February 2000 and transferred to the UN Detention Facility in Arusha, Tanzania on 30 October 2000. He made his initial appearance at the Tribunal on 8 November 2000 and pled not guilty to all charges against him.

The Defence team, headed by Mr. W. E. Taylor (USA), charges against him.
