Plea Agreement in Bisengimana Case Rejected



Trial Chamber II of the Tribunal on 17 November 05 rejected a plea agreement in the case of the Prosecutor vs. *Paul Bisengimana*, former Bourgmestre of Gikoro commune, Kigali-Rural

prefecture. The agreement was for the accused to plead guilty to some of the counts contained in an amended indictment charging him with five counts of genocide, complicity in genocide, and crimes against humanity for murder, extermination and rape. The previous indictment had twelve counts.

The Chamber composed of Judges Arlette Ramaroson, presiding, William Sekule and Solomy Balungi Bossa urged the two parties to first comply, as soon as possible, with undertakings to amend the new indictment to conform with the agreement. The Chamber noted that discrepancies between the indictment and the agreement had an impact on the unequivocal plea the accused had entered.

In the agreement the accused had pleaded guilty to count III murder as a crime against humanity and to count IV extermination as a crime against humanity. The accused pleaded not guilty to all the other counts. In response, the Prosecutor had invited the Chamber to dismiss the charges and render a verdict of not guilty in regard to the counts to which *Bisengimana* had pleaded not guilty.

The amended indictment alleges that *Bisengimana* committed the crimes in Bugesera region in Kigali-Rural prefecture. It alleges that the accused organised, planned and participated in the killing of thousands people who had sought refuge at Musha church in Gikoro. *Bisengimana* is also charged with having instigated a small crowd of Hutu civilians gathered in Musha cellule, Gikoro commune to rape Tutsi women. Several Tutsi women are alleged to have been raped as a result.

Bisengimana was arrested in Mali on 4 December 2001 and transferred to the UN Detention Facility in Arusha on 11 March 2002. He was assisted by his Lawyer Catherine Mabilie, France.

Workshop on ICTR Completion Strategy and the Transfer of Cases to Rwanda



Senior officials from the ICTR and the government of Rwanda conducted a two day workshop on the ICTR completion strategy and the transfer of cases to Rwanda. The workshop took place in Kigali from 10-11 November 2005.

Organized by the Ministry of Justice in partnership with the ICTR, the main objective of the workshop was to jointly explore the issues and strategies for developing a process of transferring cases and convicts to Rwanda as an integral part of the Tribunal's completion strategy. Participants also reviewed strategies for soliciting funds from the international community for capacity building in the Rwandan justice sector.



During the opening ceremony, Madame Eda Mukabagwiza, the Minister of Justice, said the presence of the ICTR senior officials at the workshop indicated that the ICTR belongs to the Rwandan

people and that the completion strategy calls for a corresponding strategy in Rwanda. She added that it was very important for both the ICTR and the Government of Rwanda to commit their institutions to a smooth, effective and very successful transition from Arusha to Kigali.

"We recognize the immense support provided by the European Union and the ICTR. To us this signifies support for our efforts to resolve our many post-genocide justice challenges. Indeed genocide was not just against the Rwandese people; it was a crime against humanity," the Minister said.

On behalf of the Registrar, Mr. O'Donnell thanked the Rwandan government for its efforts in organizing such an important workshop that addressed key issues concerning the completion strategy and the transfer of cases to Rwanda. He said that the Tribunal was prepared and willing to ensure that the rule of law under international standards is applied in bringing to trial those responsible for the 1994 genocide.

He pointed out that the ICTR belongs to the Rwandan people. According to O'Donnell, "if the ICTR does not work for the Rwandan people, then it would have failed in its mission." He assured the Rwandan government of the Tribunal's support in ensuring that all those still at large are arrested and brought to justice.

Speaking on behalf of the Prosecutor, the Deputy Prosecutor, Mr. Bongani Majola, said that the workshop was crucial in addressing one of the key issues of the completion strategy involving the transfer of cases to Rwanda. He emphasized that despite the planned closure of the ICTR in 2008, nobody will escape justice. He added that the Tribunal, in collaboration with the international community, will support the Rwandan government in ensuring that those who committed crimes are brought to justice.

He pointed out that the Government of Rwanda had to meet certain conditions before the transfers can be implemented. Among the conditions are exempting the transferees from the death penalty, trying indictees under international justice standards and constructing more courtrooms.

In her remarks at the closing ceremony, the Minister of Justice said the Government of Rwanda attaches great importance to the workshop and will lend its support to the recommendations and the implementation program adopted by the participants.

The workshop was attended by the Secretary General in the Ministry of Justice, Mr. Johnstone Busingye, the Secretary General in the Ministry of Internal Affairs, Ambassador, Joseph Mutaboba, the Deputy Prosecutor General, Mr. Martin Ngoga, the head of the European commission's delegation to Rwanda, Mr. David Macrae, as well as officials from civil society institutions.

ICTR Judicial Activities

• *Kalimanzira Pleads Not Guilty*



On 14 November 2005 *Callixte Kalimanzira*, former Acting Minister of Interior of Rwanda in April and May 1994, made his initial appearance before Judge Asoka N. de Silva and pleaded not guilty to three counts charging him with

genocide, in the alternative complicity in genocide, and with direct and public incitement to commit genocide.

The accused is alleged to have coordinated efforts to commence the killings of Tutsis in Butare prefecture, where Tutsis had not been subject to widespread attacks between 6 April and 19 April 1994.

He is specifically charged with giving inflammatory speeches that called for the elimination of all Tutsis, including women, children and the elderly. He is also charged with distributing weapons to be used in the massacres of Tutsis and with supervising the killings of thousands of Tutsis at their places of refuge. *Kalimanzira* is alleged to have personally beaten some Tutsis to death. The accused denied all the charges. He was assisted by a duty counsel. The date of his trial will be fixed later.

The Tribunal took custody of *Kalimanzira* on 8 November 2005 when the accused surrendered to Tanzanian authorities in Arusha.

His surrender brings to 72 the number of accused persons who have been arrested by the Tribunal.

• *Former Chief of UNAMIR Testified in Defense Case of Bagosora*



Canadian General, Romeo Dallaire, Chief of the United Nations Mission for Assistance to Rwanda (UNAMIR) was called in January this year by the Prosecutor in the Military I case. The Defense of Colonel *Theoneste Bagosora* for its

part called Dallaire's former chief and former Representative of the Secretary-General in Rwanda from November 1993 to 1994, Jacques-Roger Booh Booh to testify before the court.

A few days before the testimony of Roger Booh Booh, *Colonel Bagosora* testified before the same court on his own behalf.

Roger Booh Booh testified for two days in November 2005 during which he was examined by Raphael Constant, *Colonel Bagosora's* Lawyer.



To a question from Raphael Constant regarding the way he was received at his arrival in Kigali in November 1993, he replied:

"General Dallaire did not hand over power to me. He did not hand over any files that he has dealt with to me".

During the two days testimony, he was cross-examined by Paul Skolnik *Gratien Kabiligi's* Lawyer, Peter Erlinder for *Aloys Ntabakuze* and Rashid Rashid for the Prosecution.

Jacques Roger Booh Booh has recently published a book on his experience in Rwanda and his turbulent relationship with his subordinate, the Canadian General. Two years ago, Dallaire had also published a book on his Rwanda experience.

Cooperation with Rwanda

- **ICTR holds joint Workshop for Journalists: "Genocide, Justice and Media in Rwanda"**



From November 14 to 17, the International Criminal Tribunal for Rwanda (ICTR) and the School of Journalism and Communication of the National University of Rwanda (NUR) sponsored a joint workshop for journalists from various Rwandan media organizations. The workshop, "Genocide, Justice and Media in Rwanda," addressed several issues related to the ICTR "Media Case."

The presenters at the workshop were, Mr. Stephen Rapp, the ICTR Chief of Prosecution and Senior Trial Attorney in the media case; Dr. Tim Gallimore, the ICTR Spokesperson and Information Officer; and Mr. Jean-Pierre Gatsinzi, the Director of the School of Journalism and Communication at NUR.

Mr. Stephen Rapp talked about his involvement in the Media Case from 2001 when he began work at the Tribunal. He discussed the standard of proof needed for gaining convictions for genocide against Ferdinand Nahimana and Jean-Bosco Barayagwiza for their management of Radio Télévision des Mille Collines, as well as against Hassan Ngeze, the editor of the Kangura newspaper. Rapp explained the strategy that the prosecution team used to demonstrate how the extremist media propagated the anti-Tutsi genocide ideology and incited the public to participate in the

massacres.

The prosecutor provided evidence including 273 recordings, some showing Media Case convicts meeting with businessman Félicien Kabuga who was also indicted by the Tribunal. Rapp explained that more than 100 recordings were translated and decoded to convince the trial chamber judges that the Tutsi were presented as enemies and targeted for extermination.

Rapp also responded to the participants' questions telling them that some ICTR cases may be transferred to Rwanda. He explained that it will be necessary for Rwandan authorities to modify the law pertaining to the death penalty to comply with international legal standards before the transfers could occur.

Rapp also discussed with the journalists the importance of the Media Case for the press in Rwanda and for freedom of expression around the world when it comes to avoiding propaganda and incitement.

The participants spent the second day of the workshop analyzing the Rwandan press law and press freedom in the country. The journalists highlighted the need to develop a professional code of ethics in order to avoid violating provisions of the press law in their daily practice.

Gallimore outlined the roles and functions of the media in democratic societies. He also explained how the journalists could develop a professional practice in the Rwandan post-genocide context to assist with societal reconciliation and the promotion of peace in the Great Lakes region.

At the end of the workshop, Gallimore informed the journalists that the ICTR is ready to provide them with information on the trials going on in Arusha. He assured them that the Tribunal is hoping to establish strong partnerships with the Rwandan media in order to inform and sensitize the Rwandan public.

Journalists who attended came from the following media organizations: Ingabo magazine, Rwanda Newline, La Nouvelle Relève, Urumuli, Rushyashya, the Rwandan Association of Journalists, Radio 10, Radio Communautaire Izuba, Radio Flash, City Radio, The New Times and Imvaho Nshya.

- **Rwandan Civil Society Group Visits Tribunal**

A group of sixteen members representing several civil society organisations in Rwanda, visited the Tribunal between 21st and 25th November 2005 during which they got first hand information on the work of the United Nations International Criminal Tribunal for Rwanda in Arusha, Tanzania.

The visit was part of the move to strengthen cooperation between the Rwandan Civil Society and The Tribunal in what is called "*appui judiciaire*" to the Rwandese.

During the visit the group, held meetings with the President of the Tribunal Judge Erik Møse, the Registrar Mr. Adama Dieng and the Prosecutor Mr. Hassan Bubacar Jallow. The group also held discussions with several senior officials of the Tribunal. They discussed a number of issues pertaining to the Completion Strategy and to the current challenges.

Also discussed was cooperation between the ICTR and the civil groups in Rwanda.

News from the ICTR, Kigali

• ICTR Senior Officials Meet Kigali Staff

The Deputy Prosecutor of ICTR, Mr. Bongani Majola and Everard O'Donnell, OIC, Deputy Registrar, met on 14 November with staff members in Kigali. The purpose of the meeting was to discuss the concerns of staff members about job security and evaluation of their performance.

In his opening remarks, Mr. Majola reminded the staff about the completion strategy under which the Tribunal intends to complete all trials by 2008. The officials addressed staff members' concerns about the security of their jobs and future employment with the United Nations after the Tribunal closes.

"We are looking into the matter and discussions with the General Assembly are planned to address this. People should not be worried so much," the Deputy Prosecutor told the staff members. He also thanked the Kigali staff for their efficiency at work despite the current heavy work load and the challenges involved.

Majola also expressed satisfaction with the current relationship between the Government of Rwanda and the ICTR, saying that there has been tremendous improvement.

Everard O' Donnell also thanked the staff for their hard work and efforts. He promised the staff members that the problems raised would be attended to. He added that the administration is planning to train staff in

various fields to enhance their employment opportunities after the closure of the Tribunal.

The two officials were in the country on a 5-day mission to represent the ICTR in a joint workshop with Rwandan Government officials about the transfer of ICTR files to Rwanda and the completion strategy.

News from the ICTR, The Hague

Koffi Afande, Legal Officer, OIC, ICTR Appeals Chamber Support Unit in The Hague, was on official mission in Arusha from 31 October to 5 November 2005.

During his visit, he reviewed progress on a plan of action initiated in December and formalised and agreed upon in March/April 2005 in order to both streamline the operations of the ACSU in The Hague and strengthen operational communications with relevant Sections/Units at the Headquarters in Arusha.

He held consultations/working sessions with the Registrar, the Acting Deputy Registrar, the special advisor to the Registrar and various chiefs of Sections/Units in the ICTR. He discussed topics such as Human Resources, Witness Protection and Support, testimony by video-link, Defence Counsel, Court Management activities, External Relations and Press and Public Affairs, national/judicial authorities of various countries including the Kingdom of the Netherlands, Library and References, Internship policy, etc.

• Activities of the Appeals Chamber

On 17 November 2005, the ICTR Appeals Chamber welcomed Judge Fausto Pocar as its new Presiding Judge.

During the month of November 2005, the ICTR Appeals Chamber rendered two decisions on interlocutory appeals and eighteen pre-appeal orders/decisions. The Appeals Chamber is currently preparing to hear the *Cyangugu*, *Gacumbitsi*, *Ndindabahizi*, and *Media* cases in 2006.

From the beginning of the year, the Appeals Chamber decided appeals from Judgement in three cases (*Semanza*, *Kajelijeli*, *Kamuhanda*), issued eight interlocutory appeal decisions, and one hundred pre-appeal orders or decisions. The Appeals Chamber is seized of five appeals from Judgement (*Media*, *Cyangugu*, *Gacumbitsi*, *Ndindabahizi*, *Muhimana*), one request for review (*Niyitegeka*), and two interlocutory appeals.

• Staffing of the ICTR, Appeals Chamber Support Unit (ACSU)

The staffing of the Chambers Support Sub-Unit within the ICTR/ACSU was strengthened during the month by the arrivals of two Associate Legal Officers: Ms. Alison Cole and Ms. Kim Janssens. Prior to joining the ICTR, Ms. Cole served as Research Fellow in the Human Rights Program at Harvard Law School focusing inter alia on sexual violence prosecutions at the ICTR, ICTY, and the SCSL. She was also Legal Researcher



in the OTP at the ICTR. Ms. Janssens joined the ACSU from the SCSL where she served as Associate Legal Officer in the Office of the Registrar. Previously, she was a UN Volunteer, serving as Legal Officer with the UN Mission in Kosovo.

• **Training and Capacity-Building**

In its continuing efforts to enhance staff capacity, two members of the Language Services Sub-Unit travelled to Arusha to undertake training programmes. Charles Zama, Coordinator of the Language Services Sub-Unit attended a one week in-house training programme on the use of Multitrans, a translation preprocessing and management software in use at Headquarters and at the LSS office in Kigali. The software will soon be deployed in the Sub-Unit to help meet the Appeals Chamber's growing translation requirements. Donatus Sinsai, a self-revising translator, attended a one-month training course at the Language Services Section, in Arusha, during which he met with his revisers, all based in Arusha, for the first time, had face-to-face discussions with each of them on the corrections made to his translations, the overall intention being to enhance his translation and self-revision skills and ability to work autonomously. His stay in Arusha also afforded him greater acquaintance with Trial Chamber documents, that would foster better understanding of related appeals texts.

• **Visit of Documents Control Officer**

Jean-Antoine Milogo, Documents Control Officer at LSS, visited the ICTY where his working sessions and discussions with Ms. Robin Duska-Huff, his counterpart at the ICTY Office of Document Management, focused on both Tribunals' best practices in translation administration and document management. He also met with Judge Schomburg and several officials including the Registrar and Deputy Registrar of the ICTY and discussed Appeals Chamber translation issues with ACSU staff and senior Chambers officers. He also had discussions with translation management officials at the ICC.
