June and July Busy Diplomatic Months

ICTR has intensified its diplomatic outreach efforts in the months of June and July 2007. In mid-June 2007, the newly elected ICTR President Sir Dennis Byron, the Prosecutor, Justice Hassan Bubacar Jallow and the Registrar, Mr. Adama Dieng traveled to Headquarters in New York in order to brief the Security Council on the status implementation of the ICTR Completion Strategy, and to discuss With officials of Secretariat and various stakeholders a series of outstanding operational, administrative and diplomatic matters of crucial interest to ICTR

From 21 to 23 June 2007, another ICTR delegation made up of Prosecutor, Justice Hassan Bubacar Jallow, Mr. Adama Dieng, the Registrar, and ICTR Spokesperson Mr. Amoussouga, attended in Accra,

Ghana, a Colloquium on the Interface between Peace and the International Justice in Africa, which was organized by the Africa Legal Aid (AFLA) in cooperation with the International Criminal Court (ICC) and the African Union. Both the Prosecutor and the Registrar presented papers on the ICTR's contribution to the link between peace and international justice in Africa.

Mr. Dieng also served as moderator at the opening session of the Colloquium, which was attended by about 200 high-level representatives from various Human Rights Groups, International Institutions and Officials of the Government of Ghana, the ICC and the Special Court for Sierra Leone (SCSL). One of the key topics of discussion afforded an opportunity to the ICTR and the AFLA to agree to issue jointly the outcome of discussion held by the participants on Gender Crimes and their treatment by the international justice system throughout the world and particularly in Africa by the ICTR, whose groundbreaking jurisprudence has been unanimously praised and commended.

Following the Colloquium, Mr. Adama Dieng and Mr. Roland Amoussouga proceeded to Lome, Togo where on 25 June 2007, at the invitation of Ms. Ige Tokunbo, Director of the Togo Office of the United Nations High Commissioner for Human Rights and the Togolese Minister for National Reconciliation, the Registrar addressed a conference-debate in Lome. During the conference, he shared his ideas and thoughts with a group of lawyers, Government Officials, representatives of the civil society, journalists and members of the international community on the rule of law and transitional justice in post-conflict societies with a special emphasis on prospects for Togo moving forward towards peace and national reconciliation. The following day the

Registrar, held a meeting with the President of the Republic of Togo, His Excellency Mr. Faure Gnassingbé. The Spokesperson, the UNDP-Togo Resident Representative Ms. Rosine Sori Coulibaly, and Ms. Ige Tokunbo, also attended the meeting. The meeting focused on ways and means of enhancing the existing cooperation and judicial assistance between the Government of Togo and the ICTR, in furtherance of the ICTR Completion Strategy, as many protected and key witnesses, including senior Army Officers of Togo are often called before the Tribunal in Arusha. The meeting also reviewed the status of the Agreement on enforcement of ICTR sentences in Togo.

Interpol Calls for Action

Interpol's 19th African Regional Conference held in Arusha, Tanzania ended on Friday 13 July 2007 with a call for all National Central Bureaus (NCBs) to provide whatever assistance necessary to arrest the remaining fugitives of the International Criminal Tribunal for Rwanda.

A report submitted to delegates by the Registrar and Prosecutor General of the ICTR underlined the importance of apprehending the 18 individuals still wanted before the scheduled closure of

The President of Togo praised the ICTR for its valuable work and reiterated the full support of his Government and promised to undertake in the near future an official visit to the seat of ICTR in Arusha. Before leaving Togo for Benin, the Registrar and his delegation met with the Togolese Prime Minister, M. Yawovi Agboyibor, who also expressed his deep appreciation to the Registrar for sharing his insights on critical issues with the Togolese people during the conference held the day before. Various other issues of mutual interest regarding the best approaches to the rule of law in Togo were also discussed during this meeting.

Following its stay in Lomé, the ICTR delegation visited Cotonou, Republic of Benin, where the Registrar and the Resident Representative of the UNDP-Benin signed on 28 June 2007, a Memorandum of Understanding (MOU), which would enable UNDP-Benin to assist the ICTR in renovating the ICTR unit in the newly built Akpo-Misséréte Prison in Porto-Novo.

The signing ceremony was followed by a Press conference. Under the MOU, UNDP-Benin would oversee construction work, which shall be completed before the end of this year. Prior to the signing of the MOU, the ICTR delegation and Ms. Edith Gasana, UNDP Resident Representative were granted an audience with the President of the Republic of Benin, Dr Yayi Boni, who insisted that ICTR be given proper recognition for its admirable leadership in promoting international criminal norms and justice. The President of Benin stressed the need for all African States to support ICTR in leading the fight against impunity and corruption in Africa, two evils which have blighted African politics and governance. The President expressed further appreciation for the achievements of the Tribunal and his commitment to ensuring that constructing work on the ICTR unit in Porto Novo's prison is completed in a timely manner so that ICTR convicts could start serving their sentences in Benin as soon as possible. Finally, The Head of State pledged

to enhance his government's judicial assistance and cooperation with ICTR so as to enable The Tribunal to fully discharge its mandate within the prescribed time frame.

The Registrar also met with numerous officials through the good offices of UNDP including Mr. Jeffrey Sachs, UN Executive Director for the Implementation of the Millennium Development Goals, Mr. Gilbert Houngbo, Director of the UN Development Programme's Bureau for Africa and other Representatives of International Governmental and Non Governmental Organizations, including the President of the Republic's Principal Legal Adviser and Chairman of the Presidency's Council on economic matters. The Registrar concluded his visit by holding fruitful working sessions with the newly appointed Minister of Justice, Human Rights and Legislation and the acting Minister of Foreign Affairs. Pursuant to a proposal made by the Registrar, it was agreed to establish a joint follow-up Committee comprised of Senior Representatives of UNDP-Benin, the Ministry of Justice, the Ministry of Foreign and the State House, and other experts. This committee's main task would be to ensure a smooth implementation of the renovation project of the ICTR unit in the Porto-Novo Prison.

From 1 to 4 July 2007, in response to an invitation extended to the Registrar by His Excellency Professor Alpha Oumar Konaré, President of the African Union Commission, Mr Amoussouga Spokesperson, for ICTR represented the Tribunal at the 9th Ordinary Session of the Assembly of the Heads of State of the African Union in Accra. In addition to attending all ceremonies, events, debates and functions, the Spokeperson was mandated to raise the awareness of participants on issues of primary concern to ICTR.

the tribunal in December 2008. The request comes just weeks after Interpol assisted in co-ordinating the arrest of Rwandan genocide fugitive Isaac Kamali in France.

'It is our duty as police officers to do everything within our power to identify and apprehend those fugitives who are wanted in connection with such serious crimes,' said Interpol President Jackie Selebi.

'I urge all of our member countries, not only those in the African region, to work together to bring these people to justice.'

Officially closing the conference, President of Zanzibar Amani Abeid Karume praised the delegates for the work they had achieved.

'Regional and international gatherings like this one are extremely important. They create avenues through which member states can formulate strategies on how to identify and dismantle the criminal networks and their anti-social activities.'

Delegates at the three-day conference supported calls for enhanced border security to assist in fugitive investigations and to better tackle drugs trafficking throughout the region.

The increasing amount of drugs, particularly cocaine, being smuggled through Africa was highlighted as an area of special concern requiring greater co-ordination between Interpol's Sub-Regional Bureaus (SRBs) and NCBs in Africa and countries of production in Latin America and Asia.

To enhance the effective use of Interpol's tools in tackling transnational crime, delegates underlined the need for NCBs to occupy high-level positions within their national administrations, and agreed that a series of national awareness seminars be organized throughout the region.

Following recent successful joint operations with support from regional police chiefs' committees in Southern Africa (SARPCCO), East Africa (EAPCCO) and Central Africa (CAPCCO), delegates called on NCBs in West Africa to work with Interpol's SRB in Abidjan and WAPCCO to launch a similar operation to target transnational crime.

The conference also endorsed a recommendation calling on NCBs to each designate and inform the Interpol General Secretariat of a contact person who would identify potential vulnerable targets for terrorist or other criminal attacks.

Learning from the ICTR

"I think this is a very good idea"

An ambitious project aimed at raising awareness about International Justice among the youth in the Great Lakes Region (Rwanda, Tanzania, Kenya, Uganda and Burundi) is about to be launched by the Registrar of the ICTR, Mr. Adama Dieng. The project consists of a Painting and Essay Competition in connection with which the Tribunal has been seeking support and partnerships from different Ministries and Organizations in Rwanda including its Ministry of Education, the United Nations Development Programme (UNDP) and other UN Agencies.

From 23 to 28 July 2007 Mr. Bocar Sy, Chief, Public Affairs & Information Unit undertook a mission to

Rwanda to present, explain and discuss the project and initiate its implementation. The first phase of the project involves two countries, Rwanda, and Tanzania. The second phase to be implemented next year will involve all the countries in the Great Lakes Region.

Mr. Sy held meetings with various officials, including the Resident Representative & Resident Coordinator of the UNDP, Mr Moustapha Soumaré and his staff, the ICTR Administrative Officer, the Director General of the Rwanda Bureau of Information and Broadcasting (ORINFOR), the Deputy Director General of ORINFOR and Head of Rwanda Television, the Managing Director of New Times, the Director of Radio Flash FM and the Programme Manager of Radio Contact FM and the staff of the Press and Public Affairs Unit.

The UNDP Coordinator welcomed the project and expressed his readiness to contribute to ensuring a successful children's competition. He pointed out that such a venture came at the right time as Rwanda is working at healing its wounds from the 1994 Genocide.

"I think this is a very good idea. I will use my office to liaise with the concerned agencies and the Ministry of Education to ensure that the competition becomes a success. I am optimistic that this venture is a big asset to the promotion of Unity and Reconciliation to this prosperous nation as it would be carrying judicial message aimed at challenging Impunity," said Mr. Soumaré.

During his meetings, Mr Sy stressed that the drawings and essays submitted by school children would reflect the meaning of international justice, its contribution to national reconciliation and the fight against impunity, with the venture being expected to be part of the legacy the ICTR.

Mr Sy outlined the current status of the work at the Tribunal and its achievements to date. He talked about the outreach programme that is mainly concerned with disseminating information about the activities of the Tribunal to raise awareness among the population of Rwandan and of the Great Lakes Region. He also held interviews with journalists from Fash FM Radio Station and Rwanda's only Daily English Newspaper, the New Times.

Mr Sy also traveled to Butaré commune with Mr Innocent Kamanzi, ICTR Information Officer and the Press staff in charge of implementing the project. They identified schools in the field and assessed the effort required to implement the project and possible



obstacles during the first phase.

The UNDP, the United Nations Agencies, Ministry of Education, Media Offices are expected to be part of the major stakeholders in this venture.

Juvenal Rugambarara Pleads Guilty



Juvenal Rugambarara, the former Mayor of Bicumbi commune in Kigali-Rural Prefecture, on 13 July 2007 during his guilty plea to a single count of extermination as a crime against humanity, expressed his remorse for participating in the genocide and asked for forgiveness from the people of his commune.

Rugambarara's guilty plea follows two years of negotiations with the Office of the Prosecutor, leading to an agreement on 13 June 2007 in which the Prosecutor agreed to withdraw eight of the original nine counts confirmed against the accused.

"I pay sincere tribute to all the innocent victims of the shameful cowardice and humbly bow and plead for forgiveness from the bottom of my heart. ... I solemnly pledge to join the rallying cry of those who say 'never again'," the accused told the Trial Chamber.

Rugambarara was initially charged with genocide, conspiracy to commit genocide, direct and public incitement to commit genocide, three counts of crimes against humanity (extermination, torture, rape) and two counts of serious violations of Article 3 common to the Geneva Conventions and to Additional Protocol II.

The Trial Chamber found Rugambarara guilty of extermination because he failed, in his capacity as Mayor, to take necessary and reasonable measures to commission an investigation into the crimes committed in the commune and for the apprehension and punishment of the perpetrators.

Juvenal Rugambarara was arrested in Uganda on 11 August 2003 and transferred to the Tribunal on 13 August 2003. He made his initial appearance before the Trial Chamber on 15 August 2003 and pleaded not guilty to all nine charges. On 12 June 2007, the Prosecutor filed a request to amend the indictment by withdrawing eight charges and other factual allegations against the Accused. The Prosecutor's request was granted by the Trial Chamber on 28 June 2007.

The Accused was born in 1959 in Bumba secteur, Tare commune, Kigali-Rural Prefecture. He lived most of his adult life in Bicumbi commune where he worked as a medical officer. He was appointed Mayor of Bicumbi commune on 4 August 1993 and served from 16 September 1993 until 20 April 1994.

The Trial Chamber, composed of Judges Asoka de

Silva (Sri Lanka) (Presiding), Taghrid Hikmet (Jordan) and Seon Ki Park (Korea), scheduled a sentencing hearing for 17 September 2007.

Juvenal Rugambarara's plea is the eighth guilty plea before the Tribunal. It also brings the total number of accused persons convicted at the ICTR to 29. Five accused were acquitted.

The Prosecution team is led by Charles Adeogun-Phillips (Nigeria/UK) who led the negotiations in two previous guilty pleas. The Accused is represented by a defence team led by Mr. Maroufa Diabira (Mauritania).

• First Visit of New Chief of DASS to Kigali

Those are the words inscribed on the certificate of appreciation awarded to Ms. Tammeshe Ydnekatchew by the Staff Association in Kigali. The certificate was presented to Ms. Tammeshe Ydnekatchew by Ms. Sarah M. Kilemi, the Chief of the Division of Administrative Support Services (DASS) during her visit to ICTR Kigali office. Ms. Ydnekatchew is due to retire from ICTR on 31 August 2007 after having served the UN for over 32 years. The presentation of the certificate was made during a get together event organized by the Executive committee of the Staff Association, through the able leadership of Ms. Ruci Nailati. During her brief speech, Ms. Kilemi commended the staff of Kigali office for maintaining a family and friendly atmosphere where everybody felt appreciated. She promised to challenge the staff association committee of ICTR Arusha to learn from the good practices of their colleagues in Kigali. During the general staff meeting, Ms. Kilemi commended all colleagues for their continued positive contribution towards the realization of the Tribunal's mandate. She urged everybody to put some extra efforts now that we are close to achieving the objective of the Tribunal.

During the visit, Ms. Kilemi also opened a training workshop on Career Development and Support organized by the Training and Career Development



Unit of HRPS. The primary theme of the workshop was to training staff members on how to write a Personal History Profile and apply successfully. She told staff members that the Management of ICTR is very committed to ensuring that staff members are properly equipped with skills and adequate knowledge to enable them to compete for jobs elsewhere. She therefore promised to ensure that more training programmes aimed at career support are planned and staff members will be informed accordingly.

Ms Kilemi personally visited all offices in Kigali and met with staff from all sections/units. She also visited the Information and Documentation Centre (Umusanzu), where she was given a briefing of the activities of the centre and the various activities under the Outreach Program, which have been funded by the European Union and organized throughout the country. She also paid a courtesy call to UNDP Rwanda, and met with the Resident Coordinator.

- **ICTR Prosecution Spokesperson Briefs Media in Rwanda**

Tim Gallimore Spokesperson for the ICTR Prosecutor, held a press conference at the Tribunal's conference hall in Kigali on July 20, 2007.



Mr. Gallimore briefed both local and international journalists based in Kigali about the ICTR cases in progress and generally about the work and accomplishments of the Office of the Prosecutor as the Tribunal nears the end of its mandate in 2010.

He also briefed the media on the challenges faced by the Tribunal in tracking and arresting Felicien Kabuga and other ICTR fugitives. Gallimore told the media that he was optimistic that all the fugitives would be brought to justice before the ICTR closes its doors. He added that the Trial Chamber is now considering the Prosecutor's requests to transfer ICTR cases to Rwanda and to France for trial under the Tribunal's completion strategy.

Among the cases earmarked for transfer under the Tribunal's Rule 11 bis, are two fugitives who were arrested in France on the same day of the press conference. The Prosecutor submitted applications for transfer of the cases against Laurent Bucyibaruta and Wenceslas Munyeshyaka for trial in France. The fugitives had been living in France for some time. New arrest warrants were issued by the ICTR for the two fugitives on 21 June 2007.

Approximately 20 journalists from different media institutions attended the briefing. Wider coverage of the press conference appeared on Rwanda Television, Radio Rwanda, in the *New Times* and other newspapers in Rwanda and neighboring countries.

Gallimore's press conference was part of the periodical briefings that the Office of the Prosecutor provides to the Rwandan media.

On 21 July, Gallimore appeared on the weekly public affairs program of the University of Rwanda's campus station, Radio Salus. He answered questions in an interview with journalists at the station and questions from listeners who call into the station.

Among the topics he discussed on the program was the issue of IBUKA's recent demand that the UN give compensation to genocide survivors as part of the ICTR justice effort. Gallimore used the opportunity to correct a recent misstatement by the Deputy Spokesperson of the UN Secretary-General who told journalists in New York that the ICTR had a general fund for compensating genocide survivors. Gallimore issued a clarification that the ICTR has no such fund, nor the legal authority to provide compensation to survivors.

- **British Law Students visit ICTR Kigali**

A group of 11 Law students on a research study tour in Rwanda, July 7, 2007, visited the ICTR offices at Amahoro Building in Remera, Kigali.



The delegation was led by Mr. Howard Satterthwaite. They were briefed by Mr. Alfred Kwende, OIC Investigations, Kigali and Mr. Charles Kamuru, the ICTR Information Assistant in Kigali.

Earlier on the Students visited the ICTR's Information Centre in Kigali where they were briefed on its activities aimed at implementing the Outreach Programme in Rwanda.

News from The Hague

- **Activity of the Appeals Chamber**

The Appeals Chamber is presently deliberating on the *Nahimana et al.* and *Simba* appeal judgements and is preparing the *Muvunyi* and *Seromba* cases for hearings. Further, the Appeals Chamber is deliberating on an appeal in the *Rwamakuba* case as well as on an interlocutory appeal in the *Butare* case. It is also seized of an interlocutory appeal in the *Karempera et al.* case and of a request for reconsideration in the *Karempera et al.* case. During July, the Appeals Chamber issued a decision on an interlocutory appeal

in the *Bizimungu et al.* case, a decision concerning referral in the *Karemera et al.* case, a decision on an application in the *Niyitegeka* case, as well as decisions or orders concerning nine pre-appeal matters.

- **Hearing of testimonies of Witnesses by Video-Conference Link**

Following the Order of 27 June 2007 by Trial Chamber I, composed of Judges Erik Mose (Presiding), Sergey Alekseevich Egorov and Florence Rita Arrey, the Other Registry Services Sub-Unit (ORSS-U) of the ACSU has organised and covered, in coordination with the relevant Sections/Units of the ICTR and the ICTY, the hearing of a testimony by video-link of a witness in July 2007.

- **ICTR-Internal Co-operation and Co-operation with the ICTY, ICC and ICJ**

Mr. Daouda Niang, Chief, Language Services Section of the ICTR, visited The Hague from 06 to 14 July 2007, where he had working sessions with the OIC, ICTR, Appeals Chamber Support Unit (ICTR/ACSU) and with the members of the Language Services Sub-Unit within the ICTR/ACSU in The Hague. He also held discussions with his counterparts at the International Criminal Tribunal for the former Yugoslavia (ICTY) and International Criminal Court (ICC) within the inter-tribunal co-operation framework. He also met with Mr. Edaly GASSAMA, the Head of the Department of Linguistic Services at the International Court of Justice (ICJ), with whom he had an exchange of views on best practices.

Achieving justice for women victims of sexual violence: Are we there yet?

A roundtable on the prosecution of sexual violence at the ICTR was organized by Gaëlle Missire, a legal intern with Trial Chamber II. The roundtable took place at the ICTR on the 27 July 2007, from 11.00 to 1.00 p.m. Linda Bianchi, Florida Kabasinga and Betty Murungi were the guest speakers.

Since **Linda Bianchi** arrived at the ICTR in 2003, she has worked extensively on issues relating to the prosecution of sexual violence offences. As the first speaker, Linda talked primarily about the legal framework within which sexual violence crimes are situated, how that legal framework has evolved through ICTR and ICTY jurisprudence. She also mentions some practical implications stemming from the legal framework for the prosecution of sexual violence.

Florida Kabasinga, Assistant Appeals Counsel at the ICTR, shared her experience working with victims and witnesses of sexual violence. She talked about her time spent working on the *Muhimana* trial, from its preparation to its end. She emphasized on the need to create an enabling courtroom environment.

Betty Murungi is the Director of the Urgent Action Fund – Africa and a member of the Coalition for Women's Human Rights in Conflict Situations. She has extensive experience in women's human rights. Betty discussed the legal and in-the-field obstacles still ahead to achieving justice for women victims of sexual violence. Specifically, Betty talked about the ICTR's current provisions for dealing with victims, and referenced high-profile cases in which charges of rape were dropped. Betty also discussed the implications of reparations for victims and the ICC's Trust Fund for Victims, as well as the plausibility of reparative measures through the Nairobi Declaration.

35th Inter-Agency Games



The 2007 Inter-Agency Games were hosted by the IAEA and held in Seefeld-in-Tirol, Austria from 31 May to 4 June. The host country accorded a warm welcome with wonderful entertainment during the opening ceremony.

representation was quite good. ICTR teams took part in football, lawn tennis, pettanque and golf.
