Judge Byron Elected New President of the Tribunal

During the 17th Plenary Session on 21 May 2007, the judges elected Judge Dennis C. M. Byron (St. Kitts and Nevis) as the fourth President of the ICTR and Judge Khalida Rachid Khan (Pakistan) as the fifth Vice-President. Judge Byron replaces Judge Erik Møse (Norway). Judge Møse has served for four years, which is the maximum term according to the Rules of Procedure and Evidence. Judge Erik Møse (2003-2007) replaced Judge Navanethem Pillay (Republic of South Africa) (1999-2003) who replaced Judge Laïty Kama (Senegal) (1995-1999).

Appeals Chamber Confirms Muhimana's Sentences

he Appeals Chamber of the International Criminal Tribunal for Rwanda on 21 2007 Мау confirmed the convictions of



Mikaeli (also known as "Mika") Muhimana for genocide, rape and murder as crimes against humanity, as well as his sentences of imprisonment for the remainder of his life. He was convicted for instigating, committing, and abetting numerous crimes between April and June 1994 at various locations in Kibuve Prefecture.

The Appeals Chamber was composed of Judges Fausto Pocar, presiding, Mohamed Shahabuddeen, Mehmet Güney, Liu Daqun, and Wolfgang Schomburg.

By majority the Appeals Chamber allowed only two of Muhimana's sixteen grounds of appeal challenging his convictions and sentences. The Appeals Chamber unanimously determined, however, that

these errors did not invalidate any of Muhimana's convictions and sentences for rape and murder given his numerous other crimes, including his role in five other killings and ten other rapes. The Appeals Chamber unanimously dismissed Muhimana's remaining fourteen grounds of appeal.

Muhimana was the conseiller of Gishvita Sector in Gishyita Commune, Kibuye Prefecture from 1990 through the relevant events in 1994. Muhimana was arrested in Dar es Salaam, Tanzania on 8 November 1999. His trial commenced on 29 March 2004, and he was convicted by Trial Chamber III in its Judgement rendered on 28 April 2005. His appeal was heard on 17 January 2007.

Twenty seven trials against 33 accused have been completed. The Appeals Chamber has completed 16 trials against 20 accused and is presently seized with cases against 6 accused. Trials against 27 others are going on before the Trial Chambers. The Tribunal has so far arrested 72 accused people.





Genocide Suspect Prosecuted in the Netherlands

(Landelijk Parket, Rotterdam)

Rwandese national Michel Bagaragaza, aged 61, was arrested in his cell in Scheveningen prison by the National Investigation Service on 7 May 2007 on suspicion of participating in genocide and war crimes in Rwanda in 1994.



The National Office of the Public Prosecution Service is heading a criminal investigation against Bagaragaza under the terms of the Convention on the Prevention and Punishment of the Crime of Genocide (Implementation) Act and the Criminal Law in Wartime Act. The investigation will focus particularly on hearing witnesses

The Rwanda tribunal (ICTR) in Arusha handed over the case against Bagaragaza to the Netherlands under the Genocide Convention and the United Nations Charter in late April. This is the first time for the Rwanda tribunal to hand over a case to another country.

During the genocide, Bagaragaza was the managing director of the supervisory body for the tea industry in Rwanda and honorary president of a local Interahamwe militia. He was also a member of the MRND (Mouvement Revolutionaire National pour le Developpement), a political party closely involved with setting up militias that participated in killing thousands of Tutsis and moderate Hutus. In addition, he allegedly belonged to the Akazu, a group of persons around former President Habyarimana , who had great societal and political influence in Rwanda.


Bagaragaza is suspected of involvement in several attacks on Tutsis in the provinces of Gisenyi and Kigali-Rural during the period from 1 January until 17 July 1994. He allegedly instructed his subordinates to murder hundreds of Tutsis hiding on Kesho hill and near Nyondo cathedral. He is also believed to be involved in the founding, funding, training and arming of the Interhamwe militias. Weapons are believed to have been stored in tea factories.

Bagaragaza voluntarily reported to the Rwanda tribunal in 2005. He has confessed his role in the Rwanda genocide in 1994 and concluded an agreement with the prosecutor in the Rwanda Tribunal. For security reasons, he has been held in a cell in the international unit of Scheveningen prison since 2005.

He was be brought before the Investigating Judge in the Hague District Court on 10 May 2007.

Judge Vagn Joensen Sworn In

At a ceremony held on 2 May 2007 at the International Criminal Tribunal for Rwanda, Judge Vagn Joensen(Denmark) was sworn in as an *ad litem* judge. The ceremony was carried out by the Tribunal's President, Judge Erik Møse and witnessed by the Registrar, Mr. Adama Dieng, representing the United Nations Secretary General. Judge Joensen replaces Judge Karin Hökborg (Sweden).

Following the withdrawal of Judge Emile Short from the Karemera et al. trial due to health reasons on 19 January 2007, the two remaining judges decided to continue the proceedings with a substitute judge. On 20 April 2007, the Appeals Chamber rejected an appeal of that decision. Judge Joensen was appointed by the Secretary-General as an ad litem judge to form part of the bench in that trial.

Before joining the ICTR, Judge Joensen was a High Court judge of the Eastern High Court of Copenhagen (since 1994). He has also served as an international judge for UNMIK, Kosovo. Judge Joensen has been member of several committees in the Council of Europe and has teaching experience in criminal, constitutional and civil law at the Universities of Å rhus and Copenhagen. Judge Joensen completed his legal studies in Denmark, the United Kingdom and Harvard Law School.

Visit of the CEO of the KwaZulu-Natal Legislature

A t the invitation of the Registrar, a delegation from the KwaZulu-Natal Provincial legislature, Republic of South Africa, on 24 May 2007, concluded a four day visit to the ICTR. The purpose of the visit was to have a first-hand view of the systems in place at the Tribunal for the real-time production of transcripts of proceedings with the perspective of a possible replication in a parliamentary setup.





The delegation composed of the legislature's Chief ICTR at The Hague Executive Officer Ms. Nerusha Naidoo, Mr. Bongani Sibisi (Chief Operations Officer), Ms. Jacqueline Stone (Hansard Manager, English) and Mr. Mgondisi Ngcobo (Hansard Manager, isiZulu) had working sessions with officials of the ICTR and held talks with the incoming and outgoing Presidents of the Tribunal, Sir Dennis Byron, Judge Erik Møse and the Registrar Mr. Adama Dieng.

At the end of her visit, Ms. Naidoo said how impressed she was with the systems developed and used by the ICTR and expressed her enthusiasm to see partnerships developed between her legislature and the ICTR aimed at developing the capacity of the former in the broader area of application of technologies to strengthen the rule of law and governance. Sharing the same vision of an African Continent building its development on strong foundations such as the rule of law, the Registrar confirmed the willingness of the ICTR to share whatever know-how the institution might have developed or acquired with as many stakeholders as possible.

This visit by officials of the KZN legislature is one in a series and follows that of the Secretary General of the National Assembly of Cameroon, Mr. Samson Ename Ename during the month of February 2007. On the basis of its partnership with the National Assembly of Cameroon, the ICTR trains French speaking Court Reporters working with the National Assembly of Cameroon to the mastery of real-time skills with the possibility for the Tribunal to recruit from the same pool to attend to its own needs. This promising type of partnership is supported by a grant of the European Commission.

ICTR in Kigali

Tim Gallimore, spokesperson for the ICTR Prosecutor, was on mission to Rwanda from 28 May to 4 June. He provided a briefing to the Rwandan news media about the status of ICTR cases in progress and generally about the work and accomplishments of the Office of the Prosecutor. He also briefed the Rwandan media about the recent appeal judgment in the Muhimana case and about the progress on transfer of cases to Rwanda under the Tribunal's completion strategy.

Journalists from a variety of Rwandan media organizations attended the May 31 briefing at the ICTR office in Kigali. News reports resulting from the press briefing appeared on Radio Rwanda on 31 May, on the Rwanda Television evening news on 1 June and in the New Times on 1 June.

Gallimore also met with managers and editors of Rwandan media outlets in order to provide them with regular news and information about the OTP and to facilitate interviews and placement of OTP contributions in these media.

Activity of the Appeals Chamber

uring May, the Appeals Chamber sat in Arusha where it delivered the Appeal Judgement in the Muhimana case (21 May) and heard the appeal in the Simba case (22 May). The Appeals Chamber also rendered two decisions on interlocutory appeals in the Karemera et al. case and issued decisions or orders concerning seven pre-appeal matters.

The Appeals Chamber is presently deliberating on the Nahimana et al. and Simba appeal judgements and is preparing the Muvunyi and Seromba cases for hearings. Further, the Appeals Chamber is seized of an appeal in the Rwamakuba case and of interlocutory appeals in the Butare and Bizimungu et al. cases. It is also seized of a referral appeal in the Karemera et al case. Referral of the Bagaragaza Case to the Dutch Jurisdiction under Rule 11 bis of the Rules.

Following the Order issued on 13 April 2007 by Trial Chamber III, composed of Judges Khalida Rachid Khan (Presiding), Sergei Alekseevich Egorov and Inés M. Weinberg de Roca , the Other Registry Services Sub-Unit (ORSS-U) within the ICTR, Appeals Chamber Support Unit in The Hague has organised and implemented the first ever ICTR Rule 11 bis referral of case to a national jurisdiction and transferred custody of Mr. Bagaragaza to the relevant authorities of the Kingdom of The Netherlands on 4 May 2007.

Archives and Justice

he concept of "archives" refers to a collection of historical documents or records. It also refers to the place where these records are stored. However the definition has been considerably improved in order to match with the continuing advancements in information technology or computer science. In this regard, archives are described in more technical ways. For example, they are sometimes described as imaged documents on magnetic media or optical media in longterm storage for possible future access (copies of data on disks, CD ROM or specific types of tapes).

Archives constitute a key-element of any type of modern justice system because the judicial activity is mostly based on credible recordkeeping and record long-preservation. The records and archives matter is dealt with by several texts of the International Criminal Tribunal for Rwanda (ICTR) such as Rules 36, 81 and 109 of the Rules of procedure and Evidence, on the one hand, and by Articles 9, 10, 18, 19, 20, 32, 33 and 43 of the Directive for the Registry, on the other hand.

The above mentioned texts provide useful indications with respect to the role and the management of judicial records and archives in relation to the daily work of the Tribunal. For instance:

The Registrar (the relevant Section or Unit) has to keep a record book where all the particulars of each Case

are listed. The record book is open to the public. maintaining the Judicial Archives of the Tribunal: Case files, correspondence files, the record book, the summary of judicial activities sheet, audio and video microfiches, cassettes. diskettes, including negatives.

The Judicial Archives should be managed in total compliance with the mechanisms provided by the law. In accordance with the principle of publicity the access of the public to the documents is free and limited only by the reservations made by the law (security and confidentiality). It is also important to note that a public judicial database is available on the ICTR's website for researchers, the press and the general public. Access to judicial records in an efficient and timely manner is the right of the public.

Furthermore, the efficient judicial record keeping provides protection for the records, reliable justice and the maintenance of an environment which respects and upholds the rule of law. The attention given to this issue is illustrated by significant international gatherings of specialists such as the conference held by the Association of Canadian Archivists in St. John's Newfoundland (Canada, 29 June 2006) with the purpose of reflecting on how Archives of International Criminal Courts can aid the process of reconciliation, peace and justice. Another event of this type was the 37th International Conference of the Round Table on Archives held in Cape Town (South Africa, 20-25 October 2003) with the meaningful theme: Archives and human rights.

Visit to Yaoundé, Cameroon

rom 7 to 12 May 2007 the Commanding Officer, UNDF Mr. Saidou Guindo attended a seminar organized by the Human Rights Institute at Yaoundé, Cameroon. The main topic of the workshop was the "The Rights of the Prisoners according to the Cameroon Penal Code".

Before the workshop Mr. Guindo was invited by the Cameroon National television and radio (CRTN), Radio Sientou to discuss about the Rights of Prisoners.

On 9 May 2007, he made a presentation on the Rights of Prisoners special reference to the United Nations Detention Facility. After the presentation the participants were impressed, and they even recommended that such seminar should be extended to other regions of Africa so that UNDF could be used as a Model as regards to the right and the dignity of the prisoners as human beings.

He also met with the Cameroonian Minister of Justice who expressed his gratitude for the existing cooperation between his country and the ICTR. The Minister thanked

photographs Rwandan Supreme Court Staff Attend **Information Management Training Programme**

wo representatives from the Rwandan national judicial system visited the ICTR from 23 - 28 April for a training session focusing on information management practices and technologies. The training was facilitated by JRAU [Judicial Records and Archives Unit, Court Management Section]. Fred Gashezema, Director of ICT [Information and Communication Technology] for the Supreme Court of Rwanda. and Jean-Pierre Mbonyumugenzi, Supreme Court ICT Technician. attended the training, which was a part of the ICTR's Capacity Building and Outreach Programme. This training session was a part of a larger initiative to enhance the information management skills of the staff of Rwandan national judiciary. In the course of the past year, LLRS [Legal Library and Reference Section], IESS [Information and Evidence Support Section, Office of the Prosecutor], and JRAU have conducted several week-long training sessions for a total of approximately fifty registry staff of the Rwandan Supreme Court, the Rwandan Higher Instance Court, and the Rwandan High Court of the Republic. Because of their high level of technical expertise, the Supreme Court of Rwanda identified Mr. Gashezema and Mr. Mbonyumugenzi as focal points for this most recent training session.

The goal of the training was to equip the Rwandan ICT professionals with the necessary skills for running an efficient trial support system. Specifically, training was designed to focus on creating and maintaining records in various physical and electronic formats and to provide an overview of the concept of the lifecycle of records, from creation to maintenance to final disposition. In order to benefit as many individuals as possible, a "train the trainer" methodology was adopted; Mr. Gashezema and Mbonyumugenzi were to acquire information management knowledge and skills that could be transferred to other Rwandan judiciary staff. The training consisted of two sections: a certified training in the use and administration of TRIM [the records management database used by JRAU to maintain the ICTR's judicial documents], and an overview of the other information management systems in use throughout the ICTR.

To conduct the TRIM training section, a consultant from ComputerLand in Kampala was retained to lead a comprehensive TRIM training programme at the ICTR from 19 - 28 April. Two User Training sessions and one Administrator Training session were conducted over the course of nine days. The representatives from Rwanda participated in both the User and the Administrator Training





sessions. Additionally, more than forty ICTR staff members attended the three training sessions to enhance the knowledge of the use and administration the TRIM database within ICTR.

The trainees also met with staff from several different sections of the ICTR, including LLRS, IESS, CMS, CSS [Chambers Support Section] and EDP [Electronic Data Processing Unit] to learn about the practical use and technology behind the various information management systems that could be adapted to suit their needs.


