\* The appeal proceedings for this case were concluded by the International Residual Mechanism for Criminal Tribunals (Mechanism). Contempt of court proceedings against the same individual are currently ongoing before the Mechanism. The Mechanism was established by the United Nations Security Council on 22 December 2010 to carry out a number of essential functions of the International Criminal Tribunal for Rwanda (ICTR) and the International Criminal Tribunal for the former Yugoslavia (ICTY), which closed in 2015 and 2017, respectively.
